To strengthen organizational culture and values of honesty in working with morality. Ethics: There is no conflict of interest from performing duties. and prevent corruption and drive reform activities according to the national reform plan above. Create transparency within the agency Create values in performing duties and should be practiced as an honest culture of the Phra Sao Subdistrict Administrative Organization Therefore, the policy was announced to the executives. Sub-district employees, teachers, and all hired employees do not accept gifts. and all kinds of gifts from the performance of duties (No Gift Policy) on all festivals and special occasions, except in cases of necessity and cannot be avoided in accordance with the rules for accepting gifts or gifts. and any other benefits according to regulations Office of the Prime Minister on Giving or Receiving Gifts to Government Officials, B.E. ๒๐๑๑, accompanying the announcement of the committee. National Prevention and Suppression of Corruption on Criteria for Receiving Property or Other Benefits by Ethics of Government Officials, B.E. ๒๐๒๐ As follows:

๑. Local administrators Subdistrict employees, hired employees, employees of Phra Sao Subdistrict Administrative Organization Refrain from accepting gifts and presents of all kinds. or any other benefits as well as receiving food from outsiders who come into contact with the Phra Sao Subdistrict Administrative Organization before performing duties, while performing duties and after performing duties

๓. Local administrators Subdistrict employees, hired employees, employees of Phra Sao Subdistrict Administrative Organization Must not seek to obtain Gifts and souvenirs of all kinds or any other benefits both before performing duties While performing duties and after performing duties

๔. Congratulations expression of good wishes Reception or performance Regrets on different occasions according to tradition Expression methods should be used by signing greeting cards, greeting books, and condolence cards. or use social media instead of giving things

๕. Commanders at all levels must behave as a good example. along with supervising officials under the authority to behave well Conduct yourself correctly and strictly. As well as standing firm against all forms of corruption.

๖. Local administrators Subdistrict employees, hired employees, employees of Phra Sao Subdistrict Administrative Organization Has a duty to inform outsiders Thoroughly know the said policy.

๗. What action? Any other according to this policy Use the guidelines as specified. as well as guidelines Anything else at Phra Sao Subdistrict Administrative Organization It is considered appropriate to determine later in order to comply with this policy.
